³ An example of a **Complex Will** involves business assets, partnerships, companies, establishing trusts, life interests and right of residence (this means someone can stay in your home for their lifetime before it goes to beneficiaries).

⁴ Where fees are listed as from, additional fees (if applicable) will be charged on a time and attendance hourly rate as scheduled.

⁵ Time and attendance is charged on a part hour basis, pro rata to the applicable hourly rate.
